Sir,

This is in reference to your Application dt. 02.07.2017 filed under RTI Act, 2005 with the Institute of Secretariat Training and Management (ISTM) and received on transfer in E.IV Branch, Department of Expenditure (DoE) on 13.07.2017 vide ISTM's letter dt. 07.07.2017 for furnishing information. It is stated that E.IV Branch in DoE deals with policy making in r/o Travelling Allowance (TA) Rules for Central Govt. employees and this Branch is not concerned with the information sought in the Application.

2. It is well settled in law that as per provisions of the RTI Act 2005, the public authority can only provide that information, which is available in any material form in this Branch. The CPIO is not required to 'create' information or to 'interpret' 'information' for deducing some 'conclusion' and furnish the conclusion so deduced to the Applicant. The CPIO is also not required to give his 'opinion' or 'advice' on any matter to the Applicant. Accordingly, the information sought cannot be furnished by this Branch.
