A few days ago, It was stated by the Minister of State in the Minsitry of Personnel, Public Grievances and Pensions and Minister of State in the Prime Ministers' Office Dr. Jitendra Singh in a written reply to a question by Shri Chandu Lal Sahu, Shri Om Birla and Shri Chandra Prakash Joshi in the Lok Sabha – **Reservation Percentage for Persons with Disabilities in Appointment and Promotion** – Promotions to the higher grades are made as per provisions of the releivant Recruitment Rules. In some of the Recruitment Rules, provisions exist for promotion either on the basis of seniority in the service or through Limited Departmental Competitive Examinations. The Candidates, who do not qualify the Limited Departmental Competitive Examinations are promoted on the basis of the interse-seniority in the feeder grade.

It is therefore humbly requested to supply the following information pointwise:-

1. Reservation percentage for persons with disabilities- in PROMOTION- has been implemented in all the Central Departments ? If not please provide the information of remaining Central Department which could not implement – reservation percentage for promotion in service for PWD.
2. Number of Disable employees who got the benefits of reservation percentage for promotion in service in respective Central Department (The details must include – Name of Department –year-number of beneficiaries) in last 10 years.
3. All the Central Departments have identified the seats according to disabilities of Persons with Disabilities ? If Yes, then provide information about seats identified by Department of Posts for Persons with Disabilities particularly in DELHI CIRCLE in POST OFFICES in Postal Assistant Cadre.
4. What are the provisions of the relevant Recruiment Rules for promotions to the higher grades for persons with disabilities in Department of Posts.
5. The Details of last three such promotions offered by Department of Posts to persons with disabilities in DELHI CIRCLE in Postal Assistant Cadre in a period of last 15 years.
6. Is there any MUSTER ROLL of persons with disabilities employees is prepared in Department of Posts ? If yes, please provide a copy of that muster roll that gives a brief of persons with disabilities in Delhi Circle ?
7. If MUSTER ROLL is not prepared for PWD employees in Department of Posts then how the department of posts implement-reservation percentage for Promotion in Service for PWD – please provide complete information about procedure.
8. Is there any grievances redressal Cell specially for Persons with Disabilities in Department of Posts at CIRCLE level, provide the information about DELHI CIRCLE Cell for PWD ?
