PIO, UGC, 2016 SCC Online CIC 13355, decided on September 27, 2016 please clarify.</p> <p>In the case of Somebody getting Selected for a particular Post, and then after One Year somebody else files a Writ Petition in the Honourable High Court Challenging the Selection Process, and the Writ Petition is pending in the Honourable High Court, and Two Years of Probation has been Satisfactorily Completed by the Individual, Should or Should Not He/She be Confirmed in His/Her Post considering that the Fault Pointed Out is of the Office and Not of the Individual. Also, Individual is not Party in Writ Petition.</p>	<p>ISTM is a Central Training Institute and an attached office under Department of Personnel & Training, Government of India. The RTI application seeks information which is not held by or under the control of ISTM as a public authority. Since the RTI application seeks interpretation of an order of CIC which is not covered under the definition of "information" under Section 2(f) of the RTI Act, 2005, the information may be treated as NIL.</p>
