When will the training for ASOs selected through CGLE 2016 takes place.</li><li>2. How many batches would be made for training to CGLE 2016 candidates .</li><li>3. Is all the candidates of CGLE 2016 candidates be put in a single batch.</li><li>4. Places where the training would take place.</li><li>5. Are the batches for training chosen on rank basis or category basis.</li><li>6. What is the strength of these training batches and on what basis the strength decided.</li><li>7. What is the duration and timings of these training batches.</li><li>8. Is previous service of any candidate who join CSS after technical resignation will be counted or not.</li></ol>	<p>The schedule and venue of Foundation Training Programme for Assistant Section Officers Direct Recruit of CGLE 2016 have not been decided yet. When, decided DoPT and ISTM will inform. The matter of counting past service is governed by relevant rules under Fundamental Rules, applicability of which shall be judged only after a candidate joins the service and submits all necessary documents.</p>
