

DoPT is the cadre controlling authority for the officials/officers belonging to CSS/CSSS/CSCS services and is responsible for recruitment, posting, transfers etc. ISTM is cadre controlling authority for some isolated ex-cadre posts like MTS, Training Equipment Operator etc. for which no direct recruitment has been done in the year 2017 and 2018.
