MHA O.M. NO. 4/22/59- i) CS (a) 13-3-60 and 1.12.62 CS9A) dated 21- ii) 7-62 DP & AR 18/3/71-CS(I) dated 26.7.71 & 18/4/75-CS(I) dt. 20.6.75 The date on which the results of the final examination was declared by the ISTM.; or

The date on which the normal increment falls due 21-7-62 DP &AR after declaration of such results (which would mean Two advance increments over and above the normal increments, whichever date is elected by the persons concerned;

2) The question of converting the two advance increments into a lump sum grant has been considered in the Departmental council of the Department of personnel & A.R

The president is now pleased to decide as under:

 Those successful trainees who are working as UDCs may be granted a lump sum of Rs. 800/- (Rupees Eight hundred only and those successful trainees who are working as Assistants may be granted a lump sum of Rs. 1000/- (rupees one thousand only)

 The successful trainees may be given the choice of continued drawn of advance increments under the existing scheme and subject to the stipulations already made in the memoranda cited above. The option once exercised shall be final
