

1.	Is it mandatory for the ASO Direct Recruit through SSC CGL to join first in Institute of Secretariat Training and Management (ISTM) . Is there any scenario in which he/she can join at some other place allotted to him/her and later undergo training in ISTM. If yes, please give details.	Department of Personnel and Training, CS Division is the Public Authority to reply this query.
2.	Consider a situation in which the selected Candidate is already working in some other Department of Central Government and does not get relieved(under technical resignation) in time to join in ISTM and gets relieved after 4-5 days from the date of commencement of training . In this scenario, whether he will be allowed to join somewhere else until the next batch of training is scheduled in ISTM. If not, what will be the course of action as the candidate would have already been relieved from the previous department and next batch of training may commence after a long time(a very long time if it is the last batch of that year) . 3.	3. Can the candidate, who is already working in a department of Central Government, apply for extension in joining for two months citing personal	Any such question of interpretation and relaxation of Law/Rules and procedures may please be

If the extension is allowed and he/she gets relieved from the current department(under technical resignation) at a time when there is no new batch for training in ISTM for ASO direct recruit is scheduled, whether he/she will be allowed to join somewhere else(other than ISTM) until new training batch is scheduled in ISTM. As this information is not readily available in detail in public domain and does not breach any privacy, the information may please be provided as it is useful for large number of candidates who get selected as ASOs in CSS through SSC CGL examination.
